Bid documents will be posted on <u>www.centralbidding.com</u>. To view these, download, and receive bid notices by e-mail, you will have to register with Central Auction House (CAH). Vendors/Contractors will have the option to submit their bids and bid bonds electronically or by paper copy. Any questions about this process, contact Ted Fleming with Central Auction House at 1-866-570-9620.

Work on which Bid Proposals are invited consists of for the construction of 1,860 linear feet of steel ornamental fencing (7' height) together with vehicular and pedestrian gates, operators and access control systems.

The estimated project construction cost for this project is \$285,000.00.

Contractors desiring to bid shall hold a license for **Building Construction**, **Heavy Construction and/or Highway**, **Street and Bridges Construction** that is in full force and effect.

Every bid submitted shall be accompanied by a proposal guaranty in the form of a certified check, cashier's check or bid bond in an amount of not less than five percent (5%) of the total amount bid and shall be made payable to the Houma Terrebonne Housing Authority. Failure to do so will result in the bid/bids being declared nonresponsive and shall be cause for rejection. All bid bonds shall be accompanied by a duly authorized power of attorney and shall be guaranteed by a surety or insurance company currently on the U.S. Department of Treasury Financial Management Service list of approved bonding companies or by a Louisiana domiciled insurance company with at least an A-rating in the latest printing of the A.M. Best's Key Rating Guide or by an insurance company in good standing licensed to write bid bonds which is either domiciled in Louisiana or owned by Louisiana residents.

A **pre-bid conference**, at which the scope of the project, contract time and other requirements of the bidding and contract documents may be discussed, or any other special requirements for the project may be discussed with prospective bidders, will be held at the **Bayou Tower Complex**, 7491 Park Avenue, Houma, Louisiana at 10:00 a.m. on Thursday, August 24, 2017. A site visitation will be allowed following the Pre-Bid Conference. All bidders are encouraged to attend.

The plans, specifications and proposal forms may be obtained from **Providence Engineering and Design, LLC**, 991 Grand Caillou Road, Houma, Louisiana, 70363. In accordance with Louisiana Public Bid Law, prime bidders shall be charged a deposit of \$80.00 and, upon return of the plans and specifications in good condition within 10 days from the bid date, shall be refunded the full deposit. All other persons requesting plans and specifications shall pay a deposit of \$80.00 and shall be refunded the remainder from the cost of reproduction (\$40.00) upon return of the plans and specifications in good condition within 10 days from the bid date. The cost of mailing, if required, shall be billed separately for an additional non-refundable \$10.00 charge.

If someone other than a corporate officer signs for the Bidder/Contractor, a copy of a corporate resolution or other signature authorization shall be required for submission of bid. Failure to include a copy of the appropriate signature authorization, if required, may result in the rejection of the bid unless bidder has complied with LA R.S. 38:2212(B)(5).

A Bid will be considered responsive if it conforms in all respects with the conditions and requirements of the Bidding Documents. In order to be considered responsive, the Louisiana Uniform Public Works Bid Form must; (a) be fully completed, signed and be responsive in all respects to the Bidding Documents; (b) be made on the Bid Forms provided and submitted intact, (c) submitted in ink.

To the extent permitted by applicable state and federal laws and regulations, the Houma Terrebonne Housing Authority reserves the right to reject any and/or all proposals for just cause.
